In exercise of the powers conferred on it by section 6 (2) of the Nigerian Export Processing Zones Act, CAP. N107, Laws of the Federation of Nigeria, 2004 ("the Act") and all other powers enabling it in that behalf, the Nigeria Export Processing Zones Authority with the approval of the Honourable Minister of Industry, Trade and Investment make the following Order—

1. The Third Schedule to the Nigeria Export Processing Zones Act, Cap. N107, Laws of the Federation of Nigeria, 2004, (in this Order referred to as the "Third Schedule to the Principal Act") is amended as set out in this Order.

Amendment of the Third Schedule to the Nigeria Export Processing Zones Act, Cap. N107, Laws of the Federation of Nigeria, 2004

2. The Third Schedule to the Principal Act is amended by—

(a) inserting new items 8, 9 and 10 as follows—

"8. Petrochemical Industries,

9. Oil and gas Industries,

10. Development and Operation of Ports"; and

(b) renumbering the existing item 8 to read as item 11.

Insertion of new items 8, 9 and 10 into the Third Schedule.

3. This Order may be cited as the Nigeria Export Processing Zones Act (Third Schedule Amendment) Order, 2016.

EXPLANATORY NOTE

*(This Note does not form part of the above Order but is intended to explain its purport)*

This Order amends the Third Schedule to the Nigeria Export Processing Zones Act, Cap. N107, Laws of the Federation of Nigeria, 2004, by inserting three additional Approved Activities of the Free Zones to wit, Petrochemical Industries, Oil and Gas Industries and Development and Operation of Ports.
