In exercise of the powers conferred on the Nigeria Export Processing Zones Authority (“the Authority”) by section 6(2) of the Nigeria Export Processing Zones Authority Act, Cap N107 Laws of the Federation of Nigeria, 2004 and all other powers enabling it in that behalf, the Authority hereby makes the following Order—

1. The Third Schedule to the Nigeria Export Processing Zones Act, Cap N107, Laws of the Federation of Nigeria, 2004 (“the Third Schedule to the Principal Act”) as amended by the Nigeria Export Processing Zones Act (Third Schedule Amendment) Order, 2016 is further amended as set out in this Order.

2. The Third Schedule to the Principal Act (as amended) is further amended by—

Insertion of
new items
11, 12, 13

(a) inserting new Approved Activities as items 11, 12, 13 and 14 as follows—

- (11) E-commerce and Virtual City,
- (12) Entertainment Park and City,
- (13) Medical Park and City,
- (14) Technology Park and City; and

(b) renumbering the existing item (11) to read as item (15).

3. This Order may be cited as the Nigeria Export Processing Zones (Third Schedule Amendment) Order, 2021.
